Thawngpaang thanhtupawl nih khaan mei kanghnak kong kha an thanh theu. Thawngpaang hlattu nih biahal dingah an nawl ahcun a bia lehding le lehding kha nangmah nawl a si. A bia leh dingah naa timh ahcun an hal hlaanah zeibantuk bia dah na ka hal lai tiah hal hmasa. Meithattu zong kha an bawmtu le chimpiaktu ah na nawl khawh.

Bia an in halmi na sia-a-remlo ahcun an haltu kha ngol dingah na chimh khawh. Mei kanghnak kong an theih hlaan le hlahlainak an tuah lio ahcun thawngpaang hlattupawl sinah zehmanh chimlo kha a tthabik.

Pakhatkhat chonh ka duh hna, a hodah ka chimh khawh lai?

Inn ngeitu na si ahcun na insurance company kha a ran khawhchung in chawn hna. Minung pakhatkhat anrak thlah lai i a rawkmi le a man an in tuakpiak lai.

Innhlang na si i innchung thilri caah insurance na chiah ahcun innngeitu asiloah a aiawhtu (agent) na chonh lengah na insurance company zong kha chawn hna.

Insurance ka ngeihlo ahtah?

A rawkmi kha nangmah tein na remh a hau lai asinatein na hawi le chungkhat sinah khan bomhnak hal khawh i zuam.

Ka inn tah zaan ah a him lai ma?

Inn ngeitu na si ahcun insurance in mi pakhatkhat an thlah hlaan tiang na inn himnak tuanvo laakding kha na rian a si. Anmah nih khan ruahnak an in pek lai i a herh ahcun kenttrekta pakhatkhat kha na inn himnak tuahpiak dingah an fial hna lai. Hal ding na ngeih ahcun na sang i a ummi palek sin zongah hal khawh an si.

A rawkmi kha innung le a kampawl an si ahcun State Chungah Laakhrak Harnak Toncaan ah Mibawmtu Bu, State Emergency Service (SES) nih ruah khaangmi muka nganpipi hmang in le aa longmipawl ttempak in an in remhpiak khawh. Mei nih khan ka inn a buai ter dih. Zeitikahdah ka thianh khawh lai?

A tamdeuh cu meithatpawl nih mei hmihnak ah a thattawngmi (pressure) tipet an hman. Na inn ah rengtein na um khawhthannak hnga asikhawhchungin na innchungthilri le tthutdan-cabuipawl kha hrawhlo an i zuam.

Mei nih khan na innchung a kangh ahcun thianh a haumi pawl an um lai. Meithat Bawi, Meikanghnak Kong Hlathlaitu asiloah Palek Bawi sinah khan zeitikdah na innthianh thawk khawh a si lai tiah hal. Hlathlainak asiloah zeiruangaahdah inn mei nih a kangh ti hlatnak a um ahcun hmun cheukhat pawl ah thianhnak nawl an in pe lailo. Na insurance company zong ahkhan na insurance chiahning nih inn thianhtu an hlaanpiak khoma tiah hal hna.

Hlathlainak an tuah lioah na inn himtein chiah kha Meikanghnak Kong Hlathlaitu asiloah Palek Bawil i an rian a si. Himnak ding le hlathlainak dawnkhaanlo ding ah minung an luh khawhnak hngalo na inn kha khamnak hri in an kulh lai.

Innchung luh na herh sual ahcun Palek Bawi asiloah Meikanghnak Kong Hlathlaitu nih an in zullh lai. Hlathlainak a dih hnu ah na inn tolrelnak nawl kha nangmah an in pektthan lai.
